**NOTE:** The Mare Owner may not substitute another mare for breeding without prior consent of Talisman Farm Sport Horses.

## **2. FEES:**

The Mare Owner agrees to pay Talisman Farm Sport Horses & Ponies the following fees:

- 

Handling Fee - A non-refundable Booking/Handling Fee of \$150.00 (no G.S.T) is due for payment at the signing of this Contract.

- 

Service Fee - A Service Fee of \$450.00 (no G.S.T) is payable BEFORE the Mare leaves the stud farm after breeding or, by prior arrangement/agreement, once the mare has had a positive pregnancy scan, which must be performed prior to 21 days from the date of service.

- 

There may be charges incurred where the mare owner requires Talisman Farm to employ their AI/breeding technician (SYENZ) or Vet (Vet Services Wairarapa) to inseminate or treat Mares on the owner's behalf - these fees are to be paid promptly on invoice.

- 

Grazing Fees of \$6.00 per day for dry mares and \$9.00 per day for wet mares.

- 

Mares requiring hard feed will have the feed invoiced to the owner's account or the Mare owner can supply their own feed.

- 

The Mare Owner agrees that all veterinary and/or farrier costs are to be invoiced as an extra cost to the Service Fee. These fees along with Grazing Fees will be paid promptly upon invoicing.

- 

All invoices are to be paid in full before the mare is collected from Talisman Farm.

### **3. RESERVATIONS FOR STALLION SERVICE:**

Upon receipt of the Booking/Handling Fee we will confirm a reservation in TF Hamish's Stud book.

- 

It is the Mare Owner's responsibility to check stallion availability in advance. We would appreciate a few days notice if possible that you intend to breed your mare or are booking scan dates with your vet.

### **4. SERVICE CONDITIONS / LIVE FOAL GUARANTEE:**

The Mare will be limited to being bred on four cycles in any one breeding season.

- 

If the Mare fails to get in foal she may return the following season, but will be liable for another booking fee and any associated grazing and miscellaneous charges where required.

- 

If the Mare tests positive for pregnancy but becomes barren during gestation, she will be eligible for a return service. A veterinary certificate of barrenness must be sent to Talisman Farm within 10 days of the examination.

- 

If the Mare produces a live foal that is unable to stand or suckle and it subsequently dies (within 7 days), the Mare is eligible for a return service. A veterinary certificate must be provided to Talisman Farm within 10 days of the foal's death. It must also state that the mare was properly cared for during gestation and was attended at foaling. Failure to provide the certificate within the given period will make return of service policy null and void.

- 

If the Mare becomes un-breedable for any reason, the Mare Owner may swap the return service to another mare after gaining the permission of Talisman Farm but no refunds will be given.

- 

All rights of return to the Stallion do not include Booking/Handling Fees and grazing or other miscellaneous charges.



## **5. REFUND OF FEES:**

The Mare Owner will be entitled to a refund of the Service Fee if the Stallion dies or becomes unfit for service prior to serving the mare in the present breeding season. However we will not refund any costs associated with insemination, vet, courier etc. There will be no refunds (except as above) but the mare owner is entitled to on sell the breeding contract to another mare owner with approval from Talisman Farm.

## **6. TRANSFER OF CONTRACT:**

This contract will not be valid if the Mare is sold or otherwise changes ownership, unless prior permission is gained from Talisman Farm.

## **7. WARRANTY:**

The Mare Owner hereby releases Talisman Farm from any responsibility or liability for any disease, injury or accident to the mare or accompanying foal whilst in the care of the Stud.
